- 6. damage caused in transit, i.e. freight damage;
- 7. damage caused by improper installation, accidents (i.e. drops) or improper maintenance;

- 8. damage caused by general misuse or abuse of the product;
- 9. damage caused by climatic/environmental conditions;
- 10. wall boards that are not an exact match to website pictures, displays, samples, or previously made wall boards;
- 11. wall boards accepted with damage and not reported to the seller from which the products were purchased within 5 days of receipt.
